2. Any licensee who causes, or assists, any person in contravention of the provisions of the Emigration Ordinance, 1979, or the rules made thereunder, shall be liable to be dealt with as provided in the law.

3. Any violation of the Emigration Ordinance, 1979, or the rules made thereunder, shall render him liable to be dealt with as provided in the law.

- (i) suspension of licence ;
- (ii) cancellation of licence ;
- (iii) forfeiture of security money in part or full ; and
- (iv) prosecution in a court of law under the said Ordinance and the Rules.

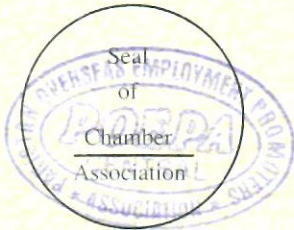

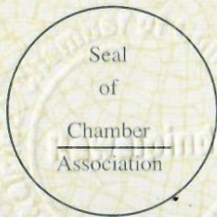
