- 2. Any licensee who causes, or assists in, the emigration of any person in contravention of the provisions of the Emigration Ordinance, 1979, or the rules made thereunder, shall be punishable n accordance with the law.
- 3. Any violation of the Emigration Ordinance, 1979, or the rules render him liable to any one or more the following measures:
 - (i) Suspension of licence;
 - (ii) Cancellation of licence;
 - (iii) Forfeiture of security money in part of fu
